1. OPENING AND PROCEDURAL MATTERS

1.1 Welcome

The Chair gave an acknowledgement of country, declared the meeting open and confirmed a quorum was present.

The Chair welcomed members and observers, particularly Dr Amanda Larkin, newly appointed member to the Board of Trustees.

1.2 Apologies

1.3 Declarations of Material Interests

The Chair invited Board members to declare any new material interests in relation to matters on the agenda or their role on the Board more generally. No new declarations were made.

1.7 Arrangement of Business

2. REPORTS

2.1 Chancellor's Report [Open Session Item]

The Chancellor spoke to his report, noting the following:

- Inaugural James Martin Institute Oration The University hosted the inaugural James Martin Institute Oration on 28 September 2022. The Hon. Dominic Perrottet MP delivered a Headland Speech on Education. The event was attended by The Hon. Sarah Mitchell MLC, Minister for Education.
- International Travel the recent trip to the UK with the Senior Deputy Vice-Chancellor and Provost was a great success, focussing on university partnerships and post-Brexit opportunities. WSU's #1 ranking in the Times Higher Education (THE) Impact Rankings ensured much interest from European universities in forming collaborations with WSU.

- *HSC Early Entry Schemes* in response to concerns raised by the NSW Education Standards Authority, the NSW Vice-Chancellors' Committee is working on a set of principles to guide the setting of early offer schemes.
- Farewell events key dates for upcoming events include Town and Gown on 29 October, the Chancellor's Formal Farewell on 16 November and a breakfast event on 23 November, and the Board of Trustees meeting and Board and Board Committee Annual Dinner on 7 December 2022.

2.2 Vice-Chancellor's Report [Open Session Item]

The Vice-Chancellor drew the Board's attention to the late paper relating to the University's promotion of its #1 ranking in the THE Impact Rankings, which will be showcased with the University's Autumn 2023 recruitment campaign and through the University's marketing channels.

The Vice-Chancellor highlighted the following items in his report: *Federal Policy Matters*

- Job-ready Graduates (JRG) package Review is currently underway, noting the transition arrangements conclude in 2024 which, combined with a softening market, will have a significant impact on the sector.
- Australian Universities Accord Review of the Australian Higher Education System the Accord process has commenced with the Commonwealth seeking feedback on the
 draft terms of reference. The aim of the Accord is to build a partnership between
 universities and staff, unions and business, students and parents, and to build
 consensus on key policy positions and national priorities. A small expert panel will
 undertake the review, with a report expected at the end of 2023.
- Review of the Australian Research Council (ARC) has commenced, with an interim report expected in December 2022.
- Teacher Education Review the Hon. Jason Clare MP announced the review. The Dean, School of Education has been asked to join the Teacher Education Expert Panel. A report is expected to be delivered by 30 June 2023.
- Mission-based Compact WSU's triannual meeting with the Commonwealth to discuss matters relating to the University's mission, vision, student load and CSPs, and the impact of government policies.

Foreign Interference

• The Vice-Chancellor attended the first University Foreign Interference Taskforce (UFIT) meeting since the Federal election. The current Government has confirmed its commitment to maintaining the legislation and will seek to reduce administrative burden for universities.

International Travel

- The Vice-Chancellor noted a successful trip to Surabaya, Indonesia, together with the Pro Vice-Chancellor International, for the purpose of exploring options for a University campus in Surabaya. The campus proposal was positively received at city and provincial government levels. The Board discussed the importance of managing the risks of regulatory/corruption issues relating to the transnational strategy.
- The Vice-Chancellor advised the Board of a number of upcoming international trips, including Taiwan and India.

Additional Commonwealth Support Places

• The Vice-Chancellor advised the Board that the University has applied for approximately 1,600 additional Commonwealth Supported Places (CSP) in undergraduate courses, as part of the recently announced 20,000 CSPs.

General Staffing Matters

• Dr Scott Snyder has been appointed to the position of Chief Information and Digital Officer (CIDO).

Summary of 2021 Census Data

• The Vice-Chancellor advised the Board that the 2021 Census Data has been analysed to inform the work underway on the regional masterplan, and that there will be a focus on Bradfield, Blacktown, and Bankstown. This will be further discussed at the Strategy Day in 2023.

The Board discussed the 2021 Student Experience Survey results, noting that the University experienced a smaller decrease in undergraduate student satisfaction during COVID, compared to others in the sector. It was agreed to bring a paper back to the Board, through the People and Culture Committee, on what drives student experience and the strategies to address it.

2.3 Academic Senate Report [Open Session Item]

The Acting Chair of Academic Senate spoke to the report, noting:

Graduate Research School Review

Professor Clive Baldock, Dean of Graduate Students and Research Development, presented an overview of the Graduate Research School Review, highlighting issues such as a lack of resourcing and a lack of a centralised HDR management system, which is soon to be implemented. Academic Senate invited Professor Baldock to provide regular updates at future meetings.

Student Management System (SMS) Update

The Chief Information Officer and Senior Manager, Student Systems presented to Academic Senate on the progress of the 'year of firsts' since the Go Live of the new SMS. Academic Senate was provided with an update on the Autumn/1H results processing.

The Vice-Chancellor advised the Board that he will meet with Ellucian to discuss the implementation of the SMS at WSU.

Committee of Chairs of Academic Boards (Co-CABs)

The Chair of Academic Senate highlighted the key points discussed at the recent Co-CABs meeting, including:

- Benchmarking issues and accreditation programs; and
- Principles of Higher Education post COVID-19.

The Board were advised that Western Sydney University will host the Co-CABs meeting in April 2023.

3.1 2023-2025 Proposed Budget [Closed Session Item]

3.2 Sustaining Success 2021-2026: In-Depth Analysis and Report - Connectedness [Open Session Item]

The Deputy Vice-Chancellor (Academic) spoke to Measure 8 of *Sustaining Success 2021-2026* – Improve student satisfaction, engagement, support, and belongingness, highlighting:

- Net Promoter Score (NPS) is the key metric for this strategic priority and is measured on completion of study. The latest score is good (27), which was collected from the April 2022 graduating cohort.
- Engagement is measured in the University's annual reflections survey and is sent to all students at the end of each year. For 2021, the engagement score was 3.8 on a 5-point scale.

The Deputy Vice-Chancellor (Academic) advised the Board that student satisfaction, engagement, support and belongingness has been challenging to measure in 2022, as students have adjusted to post-lockdown life. However, the University is tracking above average for Student Support in the Quality Indicators for Learning and Teaching (QILT) Student Experience Survey, 2021.

The Deputy Vice-Chancellor (Academic) spoke to key activities, including:

- Western Success the program has scaled up this year to support 10,000 students. Western Success uses surveys and engagement data to gain a better understanding of student needs and to provide them with personalised advice and access to relevant support services.
- Orientation The University is investing more heavily in orientation sessions as they are one of the earliest opportunities the University can engage with new students.
- Enrolment Support Webinars In 2022, the Student Services Hub initiated a series of Enrolment Support Webinars for both domestic and international students to provide them with guidance and support for enrolment and subject registration.

The Board discussed the NPS score. It was agreed to provide the People and Culture Committee with a paper to better understand what is driving the Net Promoter Score.

The Senior Deputy Vice-Chancellor and Provost spoke to Measure 9 of *Sustaining Success* 2021-2026 – Deliver positive impact for, and with, our communities and partners through social, economic, cultural and place-based transformations. The Board were advised that a survey has been developed which will be issued before the end of the year, with results to be provided in 2023.

The Senior Deputy Vice-Chancellor and Provost advised the Board that since the commencement of the new Pro Vice-Chancellor (Engagement and Advancement), there have been several activities that have further strengthened and enabled work of Engagement and Partnerships within the University.
